



Student Code of Conduct and Disciplinary Rules Undertaking

- Students shall not engage themselves in actions that are offensive to good and are disservice to the succeeding generation of students of the Institute/University.
- Political activities and the functioning of student's organization are strictly banned in the campus. Unofficial meetings, strikes, demonstrations and agitations, are strictly prohibited. Students who violate the above rules are liable to be dismissed from the University immediately.
- Students are expected to be polite individually or in groups and show respect to the Faculty (teachers) as well as to the staff of the Institute. Instructions in connection with academic or other matters as may be given by the teachers from time to time must be followed scrupulously by the students. Students must not participate in activities that may cause harm to the academic environment or which harms the teacher-student relations.
- Students are required to maintain dignified appearance. You may dress up with formal or semi- formal clothes and accessories.
- No meeting or entertainment programs shall be organized or any fund shall be collected in the Institute or the hostels without the permission of the Principal/warden.
- Identity cards should be prominently worn by students while they are in the campus, the security will not allow a student to enter University premises without their identity cards.
- Students must understand the importance of Rules & Regulations for different services at University Examination Section, Accounts Section, Resources Integrity and so on.
- Students will be responsible for all the equipment that is entrusted to them and should not misuse any of the university property. Any damage caused to any property, lab equipment and instruments, tools, books etc. shall be liable for fine. In case of any damage, actual cost will be refunded from the student along with a fine.
- Students should take the responsibility of their belongings within the campus as the University will not be responsible for any loss of belongings. Any theft or illegal behaviour by the students will be liable to strict disciplinary action.
- Use of mobiles and cameras is strictly prohibited during lectures. If a student is found using any such means then the gadget will be confiscated.
- Consumption of tobacco, alcohol or smoking is strictly prohibited inside the university campus; if any student is found under the influence of alcohol or tobacco then strict disciplinary actions will be taken against that student.
- Weapons or equipment that can hurt someone are not allowed within the university premises.
- Ragging is strictly prohibited inside and outside the university campus if anyone found guilty of ragging and/or abetting ragging is liable to be punished.
- Students should not go outside the institute building during class hours. In the event of unavoidable necessity, they should seek special permission from the Principal / Head of the Department.
- Social Medias such as Facebook, Twitter, What's App etc. are part of our daily life but it is recommended that all students maintain dignity in the content of posting/ commenting about university and staff.
- Use of abusive language, weapon, damage of property, misbehaviour with students, faculty or other staff, intimidation or interference with other students or any activity that is against the decorum of the CHARUSAT University is punishable and strict action can be taken against the student indulging into such activities.
- Discipline Committee shall have the powers to deny admission to students to classes/office/labs/library/meetings/cultural programs and other programs in the case of violation of the Student's Code of Conduct of the University.
