## Advertisement for a JRF in DST-SERB Funded Research Project

Applications are invited from the Indian nationals for filling up one positions of Junior Research Fellow (JRF) at Dr. K. C Patel Research & development Centre (KRADLE), Charotar University of Science and Technology, Changa, Gujarat under the Core Research Grant (CRG) scheme funded by Science and Engineering Research Board (SERB), Department of Science and Technology, New Delhi, Govt. of India. Position is purely on temporary basis and coterminous with the project. Details of the position is as follows:

**Position:** Junior Research Fellow (JRF)

**Number of positions:** 01 (one)

**Area:** Applied Physics, Material Science, Nanoscience

**Project duration:** 03 Years

**PI of the Project:** Dr. Vanarajsinh Solanki (Assistant Professor, KRADLE)

**Title of the Project:** Fabrication of Highly Selective Chemi-resistive Sensor for Environmental and Medical Applications.

**Age limit:** 28 years, Upper age limit may be relaxed up to 5 years in the case of candidates belonging to SC/ ST/ OBC/ Women/ Differently abled candidates.

**Emoluments (Per month):** 37000/Month + HRA for NET/JRF/GATE qualified candidate and for others as per SERB, DST norms.

**Duration:** The fellowship will be offered initially for a period of 1 year, which can be extended further depending upon performance of the candidate on yearly basis.

**Essential qualifications:** M.Sc. Physics/ Applied Physics/ Nanoscience & Technology/Material Science with minimum 55% marks. Candidates qualifying NET/JRF/GATE will be preferred.

**ROLE AND RESPONSIBILITIES:** JRF will be responsible to **synthesize various hybrid materials, characterization and its applications** related to project.

The candidature will be subjected to verification of the certificates, degree, testimonials in original as part the essential qualification/ experience etc. in person for the aforesaid position at the time of joining, in case of selection.
- The above positions are purely temporary and will be filled on contract basis. The selected candidates shall have no right/claim for regular appointment at this Institute, as the engagement is co-terminus with the Project.
- The fellowship may be terminated with a 30-day notice before completion of the tenure, if performance till date is not deemed satisfactory.
