A list of equipment is attached for your reference. If any center already has these equipment, they can upgrade their existing set up or buy the new equipment from the list.

The terms and conditions for utilization of the financial support are as follows:

1. The Remote Center will take full responsibility of utilizing funds released by IIT Bombay for the procurement of equipment and infrastructure development for the smooth conduct of T10kT workshop related activities.

2. The Remote Center will abide by the standard rules and regulations in the procurement process.

3. The Remote Center will send a proper receipt, on Institute letter head with signature of the signing authority on a revenue stamp, within a week of receiving the funds.

4. An audited Utilization Certificate *(UC)* and the details of equipment purchased *(Annexure I)* will be submitted to IIT Bombay within one month of receiving the funds.

1. **Title of the Practice**

CHARUSAT Remote Center of IIT Bombay for empowering teachers under NMEICT, MHRD, Govt. of India.

2. Objectives of the Practice

The CHARUSAT Remote Center (RC ID: 1322) is established with the following objectives:

- To empowers teachers across the nation, IIT Bombay had planned to scale up the "Train the Trainer" program under National Mission on Education through ICT which
- To improve the teaching skills of engineering college teachers of the country in core Engineering and Science subjects through live lectures are given by IIT faculty.

3. The Context

- This program had planned to train 10,000 teachers at hundreds of Remote centers spread across the country. The workshop was conducted in the distance mode, using A-VIEW software and Internet, as part of the National Mission on Education through ICT (MHRD, Govt. of India).
- CHARUSAT had become Remote Center on 19th March 2013. Hence, CHARUSAT is confirmed as Remote Center to conduct the different ISTE Workshops of IIT Bombay under NMEICT scheme.
- CHARUSAT Remote Center acts as the intermediary between IIT Bombay and the participating teachers during the workshop.

4. The Practice

Functioning of CHARUSAT Remote Center

CHARUSAT Remote Center organizes different workshops throughout the year. The workshops are organized for the different departments of the university. - Lodging and boarding facilities for participants, either in hostel or in a place near the campus.






