MEMORANDUM OF UNDERSTANDING

BETWEEN

CHAROTAR UNIVERSITY OF SCIENCE AND TECHNOLOGY (CHARUSAT)

AND

BC INSTRUMENTS INDIA PVT. LTD.

This Memorandum of Understanding is made on the 10th day of April 2018 at Changa, BETWEEN:

(a) Charotar University of Science and Technology (CHARUSAT), situated at Changa, having address at CHARUSAT Campus, Changa, Taluka Petlad, District Anand-388 421 formed under Gujarat State Act No.8 of 2009, Government of Gujarat and has empowered to award degrees by UGC u/s.22 of UGC Act, 1956 (hereinafter referred to as "CHARUSAT" which expression shall where the context so admits include its successors and permitted assignees).

AND

BC Instruments India Private Ltd (BCI) having address at Plot No.1802/4, G.I.D.C., Near ADIT College Gate, Road No.133, Vithal Udyognagar, New Vallabh Vidyanagar, GIDC, Anand, Gujarat 388121, is a high precision machine shop established in 2004 and recognized as the supplier of choice for precision machining solutions for Manufacturing High Precision Machined Components and assemblies to Aerospace, Medical Instruments, Electronics, and Power Generation. (Hereinafter referred to as "**BCI**" which expression shall where the context so admits include its successors and permitted assignees).

WHEREAS both the parties have the intentions to promote interactions in the field of Engineering & Technology and Management for various purposes like UG, PG and PhD dissertations and apprentices for Process improvements as per requirements.

NOW it is mutually agreed by and between the parties as under:

1. <u>Objectives</u>

This MoU reflects the participants' intentions to collaborate in specific activities set out herein pertaining to the field of Mechanical Engineering. The objective of this agreement is to strengthen the relation between industry and academia for quality education in the allied disciplines of engineering and Technology as well as solving industry problems by delivery or sharing of expertise.

2. Responsibilities of the parties under this MoU

Now, therefore, in consideration of the objectives contained herein, the parties hereby agree as under:

The CHARUSAT undertakes responsibility as follows:

- 1. The CHARUSAT shall identify the appropriate human resources (Faculties and students) for projects to be undertaken for BCI
- The CHARUSAT shall inform BCI immediately when the need arises of any replacement and /or modification in deployment of human resources.
- The CHARUSAT shall ensure that data/information provided by BCI shall be effectively used for the benefit of project execution purpose only.
- The CHARUSAT shall observe the BCI's policies with regard to training, Internship, placement of the students and future collaboration.

The BCI undertakes responsibility as follows:

- 1. BCI shall provide required data/ information to implement the projects to be undertaken by CHARUSAT.
- BCI shall facilitate students and faculty and students of the CHARUSAT at its location for field visit, interaction and training.

- BCI shall give opportunity to the faculty and students to intern, take training and interact with various departments of the company in order to impart exposure to professional working environment, current trends, etc.
- 4. BCI shall allow to use its name and emblem for all communications of CHARUSAT to the extent that it is used for information of students and general public and for no commercial gains.

3. <u>Procedures for activities</u>

CHARUSAT and BCI shall encourage interaction for Research and Development collaboration by their representative/s through following activities:

- (a) Conducting joint research and development projects;
- (b) Cooperation in individual projects;
- (c) Search for opportunities to collaborate in the future.

4. Intellectual Property Rights (IPR)

- (a) Rights (IPR) concerning outcomes, resulting from research projects or work funded by CHARUSAT shall be subject to the applicable CHARUSAT rules on IPRs.
- (b) Rights (IPR) concerning outcomes, resulting from research projects or work funded by BCI shall be subject to the applicable provisions in the BCI's rules.
- (c) In case where Intellectual Property Rights are generated based on inputs from both the parties, there will be a Joint ownership. In such case the generating parties will in good faith endeavor to establish a Joint Ownership Agreement with regards to allocation and terms of exercising joint ownership taking into relevant provisions on IPR. In case of conflicts arising between parties involved, an amicable solution will besought by submitting the case before an appropriate committee having representation from both parties and chaired by the Provost of CHARUSAT.

5. <u>Confidentiality</u>

Each party shall keep confidential and not use for any other purpose not contemplated hereunder, all proprietary information disclosed by the other party, directly or indirectly. Any discoveries, inventions or know-how resulting from the project shall be kept confidential for a period of **three** years from the date of termination of this agreement, except as authorized in writing by the other party or provided herein.

6. <u>Financial obligation</u>

Financial arrangement for each specific projects will be decided on a case-to-case basis and brought on record in each case after due approval from heads of both the parties.

7. Miscellaneous

(a) <u>Exclusivity</u>

The parties agree that this memorandum does not confer any exclusivity regarding activities covered by this memorandum and they may collaborate on similar activities with other parties.

(b) <u>Commencement and duration</u>

This memorandum shall operate as from the date of signature thereof ("the effective date") and shall remain binding for a period of 3 years, unless terminated prior thereto by mutual written consent between the parties. This MoU may, after expiry thereof, be renewed by the consent of both the parties in accordance of the terms and conditions of this agreement.

(c) <u>Indemnification</u>

Each party shall indemnify, defend and hold harmless the other party from and against any and all claims, demands, liabilities, settlements, damages, costs and expenses including reasonable attorney's fees and expenses, arising out of, or in

any way connected with, any default, breach or negligent non-performance of this MoU or any negligent act or omission on the part of indemnifying party, its agents and employees arising out of this conduct. Each party shall provide prompt written notification to the other party in the event an indemnified claim arises. The indemnified party shall reasonably cooperate with the indemnifying party at the indemnifying party's expense.

(d) Dispute and Settlement

This agreement shall take effect and be construed in accordance with the Laws of India and be subject to its applicable jurisdiction and at the courts of Anand. In case of any dispute or differences, whatsoever arises between parties in relation to or in connection with this agreement; both parties shall try first to resolve it amicably between themselves, failing which the matter shall be referred to and settled through arbitration. The arbitration proceedings shall be held in accordance with the provision of Indian Arbitration and Reconciliation Act.

ARTICLE 1: PURPOSE

INESC TEC and CHARUSAT hereby establish a formal affiliation for the purpose of enhancing the relationship between INESC TEC and CHARUSAT through the promotion and development of collaborative academic, research and cultural exchange programs and other cooperative activities and assistances in areas of mutual interest and benefit. INESC TEC and CHARUSAT anticipate that such activities may include any or all or the following:

- 1. Collaborative research in the Electrical Engineering and Computer Engineering main domains, not excluding other related areas in which the two parties have activity.
- 2. Exchange of students;
- 3. Exchange of documentation, research material, publication and information in fields of mutual interest;
- 4. Development, organization and hosting of joint academic and cultural symposia, conferences, workshops and meetings;
- 5. Exchange of information, advice and assistance relating to areas of mutual interest; and
- 6. Other favorable activities of mutual benefit for the INESC TEC and CHARUSAT.

ARTICLE 2: TERMS AND CONDITIONS OF PROGRAMS AND ACTIVITIES TO BE EVIDENCED IN FUTURE WRITTEN AGREEMENTS

All future programs and activities shall be subjected to the approval of both INESC TEC and CHARUSAT, the availability of appropriate financial and administrative support and compliance with all applicable laws and regulations and policies of INESC TEC and CHARUSAT. Each program and activity meeting these criteria shall be evidenced in a separate written agreement, executed

by a duly authorized representative of INESC TEC and CHARUSAT and shall describe all of the terms and conditions relating to the program or activity and its implementation, including all financial obligations.

ARTICLE 3: EFFECT OF THIS MASTER AGREEMENT

This memorandum is a master agreement and describes the arena for future projects and relationships between the INESC TEC and CHARUSAT. It is not intended to contain any specific information regarding the terms and conditions of any intended or anticipated programs and activities between the INESC TEC and CHARUSAT and specifically excludes the grant of any benefit to, or the imposition of any obligation on both INESC TEC and CHARUSAT.

ARTICLE 4: INTELLECTUAL PROPERTY RIGHTS (IPR)

IPR shall be owned by the Party that generates them. In case where Intellectual Property Rights are generated based on input from both the parties, there will be a Joint Ownership. In such case, the Generating parties, within a six (6) month period as from the date of the generation of such IPR, will in good faith endeavor to establish a joint Ownership Agreement with regards to allocation and terms of exercising joint ownership.

ARTICLE 5: CONFIDENTIALITY

Each party shall keep confidential and not use for any other purpose not contemplated hereunder, all proprietary information disclosed by the other party and marked as being "Confidential", or "Proprietary", or by any other appropriate legend. The obligation of confidentiality under the present Memorandum of Understanding shall survive its termination for a period of three (3) years).

Specific confidentiality provisions, superseding the previous paragraph in relation to a particular program or activity, may be agreed between the parties in future agreements established under Article 8.

ARTICLE 6: TERMS AND EARLY TERMINATION

This memorandum shall become effective as of the effective date and shall continue for a term of five (5) years. Thereafter, it may be renewed for additional terms upon the written consent of both INESC TEC and CHARUSAT and upon such terms and conditions as agreed to by INESC TEC and CHARUSAT at the time of renewal. Either INESC TEC or CHARUSAT may terminate this memorandum at any time upon giving at least ninety (90) days prior written notice to the other party.

ARTICLE 7: EFFECT OF EXPIRATION OF EARLY TERMINATION

If, at the expiration of the initial or any subsequent renewal term, either INESC TEC or CHARUSAT do not agree to renew this memorandum, or upon the early termination if this memorandum, all of the current programs and activities shall be terminated as soon as reasonably practicable and upon terms agreed to between the INESC TEC and CHARUSAT. All separate agreements evidencing such programs and activities shall continue in full force and effect until the cessation of the program or activity in accordance with the terms and conditions agreed between the INESC TEC and CHARUSAT.

ARTICLE 8: TERMS OF FUTURE AGREEMENTS

Each agreement which is subsequently entered into by INESC TEC and CHARUSAT to evidence a future program and activity shall contain sufficient information to fully describe the specific relationship between INESC TEC and CHARUSAT in connection with that specific program or activity and shall fully describe the benefits and obligations of both INESC TEC and CHARUSAT. In

particular, each such agreement shall address at least the following issues: 1. Each agreement shall specify the term of the program or activity but shall also reference

- 1. This Memorandum does not restrict either INESC TEC or CHARUSAT from engaging in the same or similar activities with any third party.
- 2. This Memorandum benefits only the INESC TEC and CHARUSAT and their permitted
- 3. This memorandum may only be amended in writing upon approval of both INESC TEC and CHARUSAT.

- 4. This Memorandum may not be assigned (by operation of law or otherwise) or otherwise transferred by either INESC TEC or CHARUSAT, in whole or in part, without the prior written consent of the other Party.
- 5. The relationship created between INESC TEC and CHARUSAT pursuant to this Memorandum is that of independent contractor. Neither INESC TEC nor CHARUSAT has the authority or right to act on behalf of the other Party or to bind the other Party.
- 6. Neither INESC TEC nor CHARUSAT shall use the name of the other Party or any of its officers, employees or agents in connection with any press release, advertising, promotional literature or any other publicity matters, without the prior written consent of the other Party. Notwithstanding this restriction, both INESC TEC and CHARUSAT may use the name of the other Party in general and information listings and as otherwise required by applicable law.

Edulink Education Consultancy and Placement Firm (hereinafter referred to as "Second Party"), a company registered under the laws of Royal government of Bhutan and having its registered office at Pema Apartment, Flat no. 4, Babesa Expressway, Thimphu-11001, PO Box-1796, Bhutan.

(Both referred to as parties)

1. WHEREAS

- 1.1 Parties are desirous of entering into this MOU in which CHARUSAT and Edulink Education Consultancy and Placement Firm exchange resources, knowledge, services and skills for purpose of recruiting eligible students of Bhutan to study degree programs offered by the University under various streams.

Sanjay Hospital, Nadiad (hereinafter referred to as "The Hospital") – is located at Nadiad.

Charotar University of Science and Technology (hereinafter referred to as CHARUSAT) is a University established under Gujarat Act No. 8 of 2009; having head quarter at Education Campus at Changa. Presently, CHARUSAT runs professional education programmes in Engineering, Pharmacy, Computer Application, Business Management, and Applied Sciences. Now, CHARUSAT has ventured into healthcare education.

It has started Bachelor of Physiotherapy (B.P.T.) Programme from the academic year 2009-10, Doctorate Programme (PhD) in 2011-12 and Masters of Physiotherapy Programme in 2013-14. For the training of the students pursuing this programme, CHARUSAT intends to enter into an academic MOU with Sanjay Hospital, Nadiad. Both the organizations have agreed to have such an academic MOU in the mutual interest and for the welfare of the society.

The agreement executed at Nadiad between CHARUSAT and Sanjay Hospital, Nadiad undertakes the following:

Whereas the party of first part has started B.Sc.Nursing Course under the recognition from Indian Nursing Council and Gujarat Nursing Council and has approched the party of the second part to allow use of clinical, hospital beds facilities for providing practical training to their students of B.Sc.Nursing Course.



Whereas the party of the first part will be responsible for obtaining and maintaining recognition and certification from Gujarat Nursing Council and Indian Nursing Council, State Government and any other legal authorities from time to time as well as recruit professors, Tutors, Teachers and other teaching, technical and administrative staff for their constituent college of nursing and create all other facilities to provide academic training of the required curriculum programme at their own premises.

(1) The party of the first part shall be responsible for procurement and maintenance of affiliation and recognition from Gujarat Nursing Council, Indian Nursing Council and other legal authorities including state government from time to time, Wherein the party of the second part shall bear no responsibility or liability whatsoever in respect of any derecognition etc.

- (2) After due approvals of authorities as stated in (1) and after the teaching activities has started the party of the first part shall notify the party of the second part in writing in advance about the schedule time tables and training related activities including clinical examinations etc.
- (3) The party of the First Part shall be responsible to inform these party of the Second Part in case of changes in decisions concerning training activities such as change in the schedules etc.
- (4) The party of the second Part reserves its right to alter, reject or change the clinical training time table and schedule to safeguard the intrest of the patients, its own nursing school related educational, training activities, its own priorities of undergradaute and postgraduate clinical training, examinations etc. or without assigning any reason whatsoever in any unforeseeable circumstances.
- (5) The Party of the First Part shall agree to depute its three senior most executives including the principal of the college of Nursing to be the members of the steering Co-Ordination Committee in witch the party of the Second Part will apooint its own three senior execcutives including principal of the School of Nursing to function as the Steering Committee to monitor all activities Plans, its implementation and any changes required to be monitor from time to time for the practical training of nursing students.
- (6) The party of First Part will allow and Co-Operate with the party of the Second Part for "on duty training" (Internship) to post the students in various clinical areas for their training during the period of internship and that the party of the First Part shall be responsible for giving any stipend and other benefits to be extended to such internees/Students as per the GNC & INC guidelines and norms.
- (7) The party of the First Part shall pay 25% of the tuition fees or Rs.5000/whichever is higher/per student/per term as clinical training fees to the party of the Second Part.
- (8) The party of the First part had said one-time refundable caution money deposit of Rs.4,70,000/- vide IDBI Bank ,Cheque No.969656 dated





08.05.2017 for 47 students to the party of second part towards untoward incidence of financial nature and as an advance safety against damage, pilferage, theft etc.arising out of unpredictable / unforeseen behavior of students, the second part will not pay interest against this deposit and shall be refundable the deposit after the termination of MOU, on submission of NOC to this effect by the Medical Suprientendent of the party the Second part. This will be issued after the party of the first part assures about the no legal proceedings or dues thereof against them vis-a-vis the education training provided at the institute of the party of the second part. The party of first part shall be responsible for any complications, damage and legal proceedings arising out of the training provided to the students by the patients and shall be responsible to bear the expenses of legal procedures, including compensation arising out of it.

- (9) The Party of the Second Part will have the full authorities to restrain training including termination of training of those students whose fees are not paid in advance by the First Part as per the stipulated time table every term/or have shown unacceptable behaviour by the student.
- (10) The party of the First Part shall be responsible for Identity card and uniform to their students and staff members to allow them entry into the premises of the party of the Second Part.
- (11) The party of the First Part will be awarding the Degree of B.Sc. Nursing.
- (12) The Party of the First Part will be responsible to appoint teachers and any other addional staff at their staff as their own expenses as well as bring in the needed gadgets, equipments/instruments or training to their own students at various locations of the First Part.These Nursing Students from the party of the First Part will be exposed to the training need as per the Nursing Council of India guidelines at the expense of the party of the First Part. No other facilities will be provided from the party of the Second Part to the students of the party of the First part at any future time.
- (13) This Memorandum of Understanding (MOU) will remain in force initially for a period of three years from the date of siging the MOU by both the parties

and will be at the discretion of the Board of Management of the party of Second Part for renewal, termination of any changes of parmahent pature.

Nursing Course for which/and/or for any unforeseeable reasons, reserves the right to terminate this MOU without assigning any reason for which the party of the Second Part shall give due notice atleast 6 months of one term / semester in advance to allow the party of the First Part to make alternative necessary arrangements.
- (15) The Party of the First Part will bear all the cost and pay all the charges or any legal proceeding arising out of any legal disputes, compensations, causes of accidents, thefts, arising out of the training provided to their nursing Students.
- (16) The Steering Committee meet once in every month to monitor the progess of the activities which shall be minuted and submitted for information to the Chief Executives of both the parties for any need to take follow up actions and moniter.
- (17) The party of the First Part has no role in functioning of following up the evalution, assess the activities of any other clinical functions or clinical training provided by the nursing school of the party of the Second Part to its own students.
- (18) The Party of the First Part will bear all responsibilities for moral, financial or any legal issue arising out of the training course even after the caution money deposit has been refunded by the party of the Second Part.
- (19) It is hereby agreed that for the purpose of following up of this training facilities, Principal, School of Nursing as Sheth V.S.Hospital campus, the Party of the Second Part and Principal of Nursing college at Changa, the Party of the First Part will be responsible for day to day activities of the training,etc.
- (20) It is hereby specifically agreed between the party of the First Part and the party of the Second part that in case of any difference of oinion of interpretation of terms and condition of this agreement or the functioning of

1. Preamble

Nursing students are required to learn and acquire adequate knowledge, necessary nursing skills to practice the profession of nursing including thorough and exhaustive knowledge of nursing. The nursing students are required to acquire clinical knowledge in the field of patient care and treatment. The students should learn the principles of nursing care by way of practicals at the bed side. The MTIN has enough infrastructure to provide theory knowledge of the said field but for providing practical knowledge to the student, the MTIN would like to be affiliated with the Shree Krishna Hospital for clinical training. The SKH has state-of-the-art infrastructure facilities in all the aspects and has well qualified doctors, paramedical staff, equipment, 500 beds, laboratory testing facilities and more than sufficient number of indoor and outdoor patients for in-house training of nursing students for ward teaching and clinical training. The MTIN would like to take benefit for the rich resources of SKH in the interest of their students.

2. Scope of MOU

- 1. The parties to MOU undertake to co-operate in the field of nursing and patient care.

Any communication or notice or information or proceeding shall be addressed to the co-ordinator of the respective parties and sent to the requested address of the parties concerned and such a communication sent by e-mail, tele-fax, registered post shall be deemed to the sufficient and acceptable.

6. Effective date and duration of the MOU

Mode and Methodology of operations at Shree Krishna Hospital, Karamsad.

- 1. All the student of MTIN will attend the clinical training in SKH premise in the schedule time through mutually developed timetable. The said schedule will not be arranged in the manner that the training schedule of Mandal's institutions will be affected.
- 2. M.Sc. Nursing students will allowed for their research purpose with proper permission from SKH higher authorities.
- 3. At a time one batch i.e. 20 students will be allowed for clinical training in the Hospital.
- 4. The student will attend the said clinical training in the Hospital with wearing a uniform.
- 5. SKH will not provide any place or facilities for changing their uniform or keeping their belonging in the Hospital and the SKH is not liable for safe custody of their belonging.
- 6. In case of illness or injury or otherwise the student if required medical treatment in this Hospital, treatment will be available on payment basis only. No concession or relief will be given to the student.
- 7. During the clinical training if any damages or loss or otherwise any kind of incident caused by the student or staff of the MTIN, MTIN will be responsible for making payment of such damages or loss to the SKH.
