The 28th meeting of the Board of Studies in Pharmacy was held on Saturday, 2nd April 2022, at 10:00 a.m. in the Conference Room of Ramanbhai Patel College of Pharmacy, CHARUSAT.

The Chairperson of the board of studies in Pharmacy greeted the members and invitees to the meeting. The meeting proceeded with the agenda.

Item No. 28.1: To approve the minutes of the 27th Joint Meeting of Board of Studies and

Faculty Board of Pharmacy held on 15th September 2021.

Proceedings: Minute of the 27th Joint meeting of the Board of Studies in Pharmacy and

Faculty Board of Pharmacy was circulated to the members for review through e-mail (9th October 2021) [Enclosure-2]. There were no suggestions received.

Resolution: The minute of the meeting was confirmed by the members of the Board of

Studies in Pharmacy.

Item. No. 28.2: To review and recommend the scheme of teaching and evaluation, including

syllabi of various courses for M. Pharm programs [(i) M. Pharm (Phytopharmacy and Phytomedicine) and (ii) M. Pharm (Pharmaceutical

Chemistry)].

Proceedings: Dr. Manan briefed the members about the process adopted for the framing of

syllabi. He shared the summary of the subgroup meeting. The subgroups were constituted to frame the draft curriculum of M. Pharm programs [(i) M. Pharm (Phytopharmacy and Phytomedicine) and (ii) M. Pharm (Pharmaceutical

Chemistry)] [Enclosure-3]. The members reviewed the draft curriculum

and the suggestions made by the subgroups.

Following were the suggestions received from the board members, which were accepted to be incorporated into the curriculum.

Dr. Lal Hingorani:

- 1) To offer a certificate course on "Development of Herbal Formulations" to the students.
- 2) To impart knowledge in identifying the adulteration in herbal drugs.
- 3) To explore the scope of offering a certificate course on "Entrepreneurship" to the students

Mr. Hardik Soni suggested:

- 1) To incorporate the topics of regulatory requirements for Herbal and Nutraceuticals formulations.
- 2) To incorporate the topics of Quality Control, Quality Assurance for Herbal and Nutraceuticals formulations.

Dr. Tejal Mehta suggested:

1) To explore the possibility of offering a certificate course on "Neutraceuticals, Food and Phytopharmaceuticals."

It was resolved to incorporate the suggestions and recommend the scheme of teaching and evaluation, including syllabi of various courses in the M. Pharm program [(i) M. Pharm (Phytopharmacy and Phytomedicine) and (ii) M. Pharm (Pharmaceutical Chemistry)] [Enclosure-4]. It was also resolved to explore the feasibility of offering certificate courses.

To review and recommend the modification in the scheme of the teaching and evaluation, including the syllabus of various courses for M. Pharm programs [M. Pharm(Pharmaceutical Technology), M. Pharm (Quality Assurance), M. Pharm (Pharmacology), M. Pharm (Pharmacy Practice), and M. Pharm(Regulatory Affairs)]in line of the curriculum proposed by the Pharmacy Council of India.

The current curricula of various M. Pharm programs have alignment with the curriculum proposed by the Pharmacy Council of India, with few modifications. It was proposed to adopt the curriculum as suggested by the Pharmacy Council of India without modifications. It was also suggested that, considering the inherent diversity of the curricula, PG students might be offered add-on courses to enhance the knowledge and skills. The need to incorporate an industrial training component (three-week duration) as a part of the extra credit component was discussed. It was proposed to incorporate the courses to be offered by the Department of Humanity and Social Sciences and University Electives as a part of the curriculum.

The members agreed to adopt the curriculum recommended by the Pharmacy Council of India for all M. Pharm programs of CHARUSAT as proposed by the Pharmacy Council of India. The Industrial Training component (three-week duration) is to be incorporated as a part of the extra credit component. The members of the board authorized the Dean-Faculty of Pharmacy to incorporate courses to be offered from the Department of Humanity and Social Sciences and Inversity Electives as a part of the curriculum. The members were briefed about the UG ad PG elective courses offered by the Faculty of Pharmacy as University Elective courses. The syllabi of three new courses to be offered as University electives were proposed. The courses entitled 1) Cosmetics in Daily Life, 2) Intellectual Property Rights, and 3) Clinical Data and Interpretation. Cosmetics in Daily life and Clinical Data and Interpretation were proposed to be offered as a practice-based course, while Intellectual Property Rights would be offered as a workshop-based course. Following suggestions were received from the experts after reviewing the draft syllabi; The suggestions were considered and incorporated.

Dr. Tejal Mehta suggested:

 To incorporate the topics of regulatory requirements for cosmetics into the certificate course on "Cosmetics in Daily Life".

Dr. Lal Hinglorani and Mr. Hardik Soni suggested:

1) To incorporate the topic related to copyright in the syllabus of Intellectual Property Rights.

Resolution:

It was resolved to recommend the syllabi of all elective courses after incorporating the suggestions. [Enclosure-6]
